We aim to ship your order within 10 – 14 days of purchase. UK orders are usually shipped via APC Couriers next day delivery or 1st Class signed for. Orders can take up to 15 working days to be delivered through Royal Mail, but should usually arrive in 1-5 working days. If you have not received your order by the times stated please let us know as soon as possible, we will be unable to help you if more than 3 months have passed from the date of dispatch.
